MAY 2021 MINUTES

The George City Council met in regular session on Wednesday, May 12, 2021, in the Community Room, 115 S Main Street, with Mayor James L. Cuttell presiding. Mayor Cuttell called the meeting to order at 7:00 p.m. The roll was called by Mayor Cuttell. Present were Ande Bruinsma, Stacy Denekas, Nyron Moore, Warren Tiedeman and Carola Vivian. Absent was none.

Vivian made a motion to adopt the agenda. Tiedeman seconded the motion. All present cast aye votes, motion carried.

OPEN FORUM: Mark Stueven contacted the city about selling firewood down at the campground. It will be a free will donation and the funds will to go to the City to offset campground expenses. Council agreed that this would be acceptable.

Mayor Cuttell opened the Public Hearing at 7:09 p.m. to present the Budget Amendment for Fiscal Year 2021. The notice was published in the Lyon County News on April 29, 2021 and posted to the door on April 29, 2021 as required by law. There were no written or oral comments. The Public Hearing session was closed at 7:10 p.m. Tiedeman introduced the following **Resolution No. 2021-05-312** entitled "RESOLUTION TO APPROVE THE BUDGET AMENDMENT FOR FISCAL YEAR 2020-2021" and moved that the same be adopted. Vivian seconded the motion to adopt. Roll call vote –ayes: Bruinsma, Denekas, Moore, Tiedeman and Vivian, –nays: none. Motion carried.

Bruinsma made a motion to approve the consent items. Tiedeman seconded the motion. All present cast aye votes, motion carried.

Tiedeman made a motion to accept the May 1, 2021 changes to the George Swimming Pool Lifeguard Manual. The updates included the change in entry fees: for children 4-17 the fee changed from \$3.25 to \$3.00 and for adult 18+ the fee changed from \$4.25 to \$5.00. All job descriptions are now included in this manual. Denekas seconded the motion. All present cast aye votes, motion carried.

Vivian made a motion to terminate the agreement signed on May 14, 2020 with The Road Guy that was proposed to seal coat streets. The contractor has made little to no effort to contact the city for the work. Denekas seconded the motion to terminate. A letter will be sent to The Road Guy via certified mail. All present cast aye votes, motion carried.

Council reviewed a new agreement from Pearson Bros, Inc to seal coat the streets. Denekas made a motion to sign the agreement with Pearson Bros to begin work this summer on seal coating streets. Vivian seconded the motion. All present cast aye votes, motion carried.

Update from the swimming pool is that the painting project is complete. Thank you to the Keep Iowa Beautiful Grant and the Lyon County Riverboat Foundation non-competitive funding to fund the project. The council was updated that there is a possibility that they will need to replace the strainer system as there are no replacement parts and the company is out of business. More information will be presented at a later date.

Update on the sealed bid submitted to the GLR Community School for excess playground equipment. The school board accepted the bid and the city employees have started to take out the equipment to bring to shop to work on before it is relocated to Kinder Platz park. The City Clerk is obtaining quotes to update and replace the slide at Kinder Platz park.

Citywide Cleanup Days set for next week May 18 & 19 the city hopes to see everyone participate and clean up their homes.

Discussion continued regarding the request from Last Call Saloon to sponsor a "Burn Out" Contest. Last Call checked into insurance and they are able to cover the liability. The George Fire Department will be on the scene for assistance as needed. Vivian made a motion to approve the request from Last Call to sponsor a "Burn Out" Contest during Freedom Days Celebration on July 3. The motion failed due a lack of a second.

There was no update regarding the proposal of land purchase at GEORGE AGRIC LAND GEORGE O.T. 100' X 150' ABAND RR R-O-W LYING NE OF BLK 31.

Denekas introduced the following **Resolution 2021-05-313** entitled "RESOLUTION TRANSFERRING MONEY FROM THE WATER CASH ACCOUNT AND SEWER CASH ACCOUNT TO THE WATER/SEWER RESERVE CASH ACCOUNT FOR FUTURE EXPENSES" and moved that the same be adopted. Tiedeman seconded the motion to adopt. Roll call vote –ayes: Bruinsma, Denekas, Moore, Tiedeman and Vivian, –nays: none. Motion carried.

Tiedeman introduced the **Ordinance 255** entitled AN ORDINANCE AMENDING TITLE VI BUILDING REGULATIONS; CHAPTER 8: FLOODPLAIN REGULATIONS; ARTICLE 15 GENERAL PROVISIONS and moved that the requirement that the ordinance be considered at two prior council meetings be waived. Denekas seconded the motion to waive the requirement that the ordinance be considered at two prior council meetings. Roll call vote –ayes: Bruinsma, Denekas, Moore, Tiedeman and Vivian, –nays: none. Motion carried. The Mayor declared that the motion to waive the requirement that the ordinance be considered at two prior council meetings has been passed by a vote of not less than three fourths of the council. Denekas then moved that the proposed ordinance be adopted. Tiedeman seconded the motion to adopt. Roll call vote –ayes: Bruinsma, Denekas, Moore, Tiedeman and Vivian, –nays: none. Motion carried. WHEREUPON, the Mayor declared this ordinance to be adopted by a vote of not less than three fourths of the council.

Tiedeman made a motion to approve the Cigarette/Tobacco Permits for Casey's, Total Stop and Dollar General. Bruinsma seconded the motion. All present cast aye votes, motion carried.

Tiedeman made a motion to approve the Alcohol and Liquor License for Flower Boseconded the motion. All present cast aye votes, motion carried.	x. Vivian
