Council would like to have Todd Klein attend the August council meeting to review the DNR 5-year plan details.

Council was recapped that Pearson Bros, Inc will seal coat the streets and they will be here around August 19.

The swimming pool still has a leak and the council would like a letter sent to Leak Investigators for them to return when the pool closes and determine where our pool is still leaking. The tentative last swimming day will be August 22 unless sooner due to scheduling.

Council would like Sheriff Vander Stoep attend the August council meeting to review deputy coverage for the city and discuss the concern with golf carts being operated by underage operators.

Tiedeman made a motion to approve the request for an outdoor event and street closure (from north side of Total Stop driveway to Iowa Ave) for Last Call 2 to be held on August 14. Vivian seconded the motion. All present cast aye votes, motion carried.

Vivian made a motion to approve the request from Zomer Auction on a street closure for Korthals household auction scheduled for August 7. The closure will include E Minnesota Ave from Virginia St to Wilhelm St. Moore seconded the motion. All present cast aye votes, motion carried.

Council was informed by Klassen Realty & Auction that they would be occupying Oak St. for the online auction sale pick up. The road is a dead and the council didn't see any issue with this request.

Council discussed the street installation to happen on Lacour Street between Dollar General and Mitchell & Huss Excavation. The council received 4 bids to review for the project. Bruinsma made a motion to accept the bid from VMC Construction with the bid not to exceed \$44,997.20. Tiedeman seconded the motion. All present cast aye votes, motion carried.

Council would like a follow-up to review the schedule on mosquito spraying for the City of George and Matlock.

Council received a resignation letter from Lance Kruse, Public Works Technician last day of employment July 23, 2021. Vivian made a motion to accept the resignation from Kruse and to start advertising immediately. Denekas seconded the motion. All present cast aye votes, motion carried.

Next monthly council meeting will be held August 11, 2021 at 7:00 p.m.

Denekas made a motion to adjourn at 8:08 pm. Tiedeman seconded the motion. All present cast aye votes, motion carried.
