Denekas made a motion to approve a donation of \$1,000 to support Mid-Sioux Opportunity as they currently serve 139 residents of George. Vivian seconded the motion. All cast aye votes, motion carried.

Tiedeman made a motion to approve the Alcohol/Liquor License and organization structure for Casey's General Store. Bruinsma seconded the motion. All present cast aye votes, motion carried.

Bruinsma made a motion to adjourn at 7:55 pm. Tiedeman seconded the motion. All present cast aye votes, motion carried.
