Council discussed the installation of cameras at the depot and the city shop. Gruis made a motion to purchase 2 cameras for the shop and 2 cameras/1 wireless bridge for the depot. Vivian seconded the motion. All present cast aye votes, motion carried.

Council discussed replacing furnaces at the north community room and the city office. Tabled for more information.

Gruis introduced the following **Resolution 2023-10-402** entitled "RESOLUTION APPROVING THE TRANSFER OF FUNDS FROM GEMS SAVINGS, GEMS CD AND CASINO SAVINGS ACCOUNTS TO THE GENERAL CASH ACCOUNT TO OFFSET THE PURCHASE OF AN AMBULANCE". Johnson seconded the motion to adopt. Roll call vote: – ayes: Bruinsma, Gruis, Johnson, Tiedeman and Vivian, –nays: none. Motion carried.

Vivian introduced the following **Resolution 2023-10-403** entitled "RESOLUTION TRANSFERRING MONEY FROM THE GENERAL FUND TO THE LOCAL OPTION SALES & SERVICE FUND REGARDING THE LOAN REPAYMENT OF FUNDS FROM GEORGE COMMUNITY ECONOMIC DEVELOPMENT CORPORATION". Bruinsma seconded the motion to adopt. Roll call vote: –ayes: Bruinsma, Gruis, Johnson, Tiedeman and Vivian, –nays: none. Motion carried.

Council reviewed the building permit application received for Tabernacle Baptist Church and discussed the fees for building permits. Vivian made a motion not to waive the building permit fees for the school or the churches. Bruinsma seconded the motion. All present cast aye votes, motion carried.
