Council asked that the City Clerk to start advertising for summer help in the areas of mowing, street help and swimming pool staff.

Kristi Donaker, Library Chair discussed with the council the wages for the library employees. Donaker indicated that they were unaware of the city wage increases because their board meets before the city council does. She feels it is appropriate to compensate the librarians for the years that the city employees received more of a wage increase than the library employees. Donaker proposed to the council the following raises Kayla Gerloff from \$17.50/hour to \$19.50/hour, Pat Bruinsma from \$14.42/hour to \$15.25/hour, Becky Stueven from \$12.36/hour to \$13.00/hour and Gregory Stueven from \$8.24/hour to \$8.25/hour.

Vivian introduced the following **Resolution No 2024-02-413** entitled "RESOLUTION SETTING THE SALARIES FOR EMPLOYEES OF THE CITY OF GEORGE FOR THE FISCAL YEAR 2024-2025" and moved that the same be adopted. Wage increases will be as follows: Todd Klein \$27.06/hour; David Grave \$22.71/hour; Cole Riemersma \$21.36/hour; Loralye Wibben \$47,586/year; Emily Denekas \$15.91/hour and Barb Wessels \$17.24/hour (city) & \$16.71/hour (fire station). The Library Board set wage increases for library staff as follows: Kayla Gerloff \$19.50/hour; Pat Bruinsma \$15.25/hour; Becky Stueven \$13.00/hour and Gregory Stueven \$8.25/hour. Gruis seconded the motion to adopt. Roll call vote –ayes: Gerken, Gruis, Hamilton, Storm and Vivian, –nays: none. Motion carried.

Gerken introduced the following **Resolution No 2024-02-414** entitled "RESOLUTION DISTRIBUTING THE HEEREN ESTATE TO THE GEORGE FIRE DEPARTMENT/GEORGE EMERGENCY MEDICAL SERVICE FOR LAND PURCHASE" and moved that the same be adopted. Storm seconded the motion to adopt. Roll call vote –ayes: Gerken, Gruis, Hamilton, Storm and Vivian, –nays: none. Motion carried.

Vivian introduced the following **Resolution No 2024-02-415** entitled "RESOLUTION TRANSFERRING MONEY FROM THE WATER CASH ACCOUNT AND SEWER CASH ACCOUNT TO THE WATER/SEWER RESERVE CASH ACCOUNT FOR FUTURE EXPENSES" and moved that the same be adopted. Hamilton seconded the motion to adopt. Roll call vote –ayes: Gerken, Gruis, Hamilton, Storm and Vivian, –nays: none. Motion carried.

Mike Carr discussed the sanitary sewer lining project with the council and the procedures that to lead to the bid letting, financial effects on the income to debt ratios and the schedule. March 8 bids will be read. March 13 a bid will be the accepted.

Gruis made a motion to accept and sign the engagement letter with Dorsey & Whitney LLP (bond counsel) and DA Davidson (municipal advisor). Vivian seconded the motion. All present cast aye votes, motion carried.

PROCEEDINGS TO SET DATE FOR HEARING AND LETTING: The City Council took up and considered the proposed Sanitary Sewer Rehabilitation Project. Gruis introduced the **Resolution No 2024-02-416** entitled "Resolution to provide for notice of hearing on proposed plans, specifications, form of contract and estimate cost of the Sanitary Sewer Rehabilitation Project and the taking of bids therefor" next hereinafter set out and moved its adoption, seconded by Vivian. After due consideration thereof by the Council, the Mayor put the question upon the adoption of the said resolution and the roll being called, the following named Council Members voted: –ayes: Gerken, Gruis, Hamilton, Storm and Vivian, –nays: none. Motion carried. Whereupon, the Mayor declared the motion duly carried and the resolution adopted.

Gary Kurth discussed the Virginia Street Project with the council. Due to the multiple widths of the road ranging from 24 foot wide to 42 feet wide so the council decided it would be best to install a 31-foot B/B street and install drive over curb to allow parking by the church on Virginia Street. Recommend 6" aggregate base under 8" concrete. Discussion on installing more storm sewer and drains on Virginia St. Discussion on installing an 8-inch water main under Virginia St.

Vivian made a motion to donate \$150 to the George-Little Rock After Prom Committee for the 2024 After Prom Activities. Hamilton seconded the motion. All present cast ayes, motion carried.

Next monthly council meeting will be held March 13, 2024 at 7:00 p.m.

Hamilton made a motion to adjourn at 9:41 pm. Gerken seconded the motion. All present cast aye votes, motion carried.
