SPECIAL MEETING

The George City Council met in special session on Wednesday, April 2, 2025 in the Community Room, 115 S Main Street, 120 S Main Street, with Mayor Billy Sprock presiding. Mayor Sprock called the meeting to order at 6:00 p.m. The roll was called by Mayor Sprock. Present were: BJ Gerken, Bob Gruis, Derek Storm and Carola Vivian. Absent: Kris Hamilton.

The Mayor may hire additional street help as needed in vacation of council meetings and will report any changes at the next meeting. Gruis seconded the motion.
