Taylor Klingenberg, GCEDC member presented to the council proposed changes to the 28E Agreement between the City of George and George Community Economic Development Corporation (GCEDC). Due to the increase of rent the over the past two years the GCEDC is requesting a \$6,000.00 increase to the current asking. Council reviewed the 28E agreement and agreed to accept the request and prepare a new 28E agreement to take effect July 1, 2026.

Council received a bid from Concrete Surfacing Inc. to re-paint and texture the inside of the locker rooms and guard shack and re-coat the black lines in the swimming pool. Storm made a motion to accept the bid, with the project to begin Spring of 2026. Gerken seconded the motion. All present cast aye votes, motion carried.
